### LOCATION

The property occupies a prominent location in Barnsley town centre, with good access from the A628 and A635. Junction 37 of the M1 is easily accessible 1.5 miles west via the A628.

The ground floor of the building is let to Dominos, British Heart Foundation and a European food market. Other nearby occupiers include Lidl, Quality Save, Costa Coffee, Iceland Foods and both a KFC and Taco Bell drive-thru.

### DESCRIPTION

The available property is arranged over first floor with frontage and access at street level from Peel Street. There is also street level loading access directly into the first floor via the service yard at the rear.

The property comprises a largely open plan retail space with staff office, kitchen and wc facilities at both first and second floor.

With Class E planning consent the space is suitable for a variety of uses including leisure, retail, office and storage.

The rear service yard has parking for 1-2 vehicles, loading access and a bin store.

The property has recently undergone a full refurbishment.

### ACCOMMODATION

The unit has a Net Internal Area of **11,502 sq.ft. (1,068.57 sq.m)**
